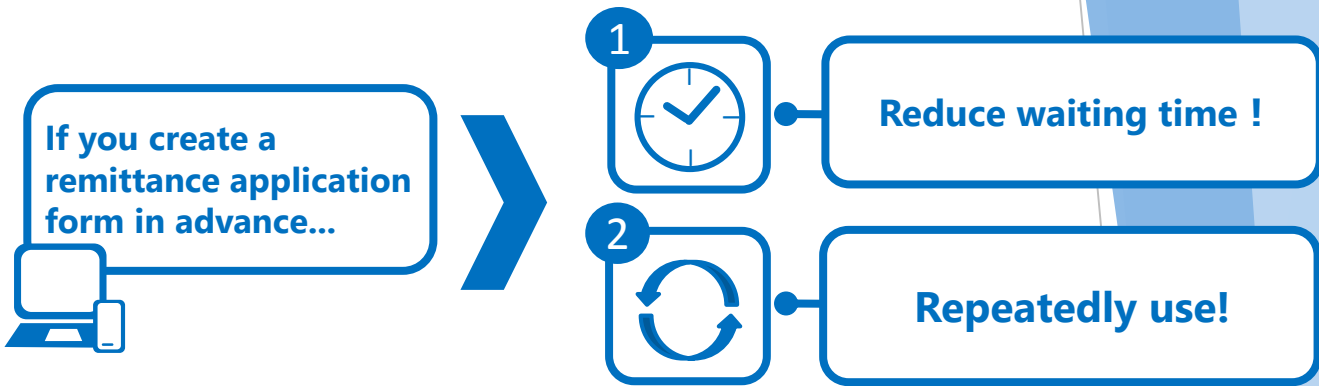

◎ Please pay attention to the field where you enter an address. Please ready for your correct address and enter it in the appropriate field.

◎ Please be sure to enter the state name for the United States, Canada, and Australia, and the province name for China.

3. Information required

◎ Beneficiary bank information

☐ **BANK NAME**

- We may ask you to check **SWIFT CODE** (a code that identifies bank).
- You may be asked to specify a transit bank.
- Depending on the country where the recipient bank is located, a country-specific bank identification code may be required.

☐ **BANK BRANCH OR BRANCH ADDRESS**

☐ **CITY AND COUNTRY**

- Please be sure to enter the state name for the United States, Canada, and Australia, and the province name for China.

◎ Information about the recipient

☐ **BENEFICIARY'S FULL NAME**

- Full name must be entered. Initials such as middle names are not allowed.

☐ **BENEFICIARY'S ADDRESS AND COUNTRY**

- Address using P.O.BOX is prohibited.
- If the destination country is Canada, you need the postal code, and if the destination country is South Korea, you need the beneficiary's phone number.

☐ **BENEFICIARY'S ACCOUNT NO.**

- For European countries that adopt IBAN, an IBAN is required. (IBAN: A code that identifies the country where the account is located, bank name, branch, and account number)

◎ PURPOSE OF THE REMITTANCE

- Please declare the detailed purpose of remittance in English.
ex) LIVING EXPENSES, TRANSFER, GRANDCHILD'S ADMISSION GIFT MONEY

4. Documents required

◎ Identification

ex) Residence card, Passport, Individual Number Card

◎ Documents that can confirm your personal number(Individual Number Card) or corporate number

◎ Documents that confirm the purpose of remittance

- You may be required to present documents that can confirm the details of the transaction, such as the source of the remitted funds, the purpose of the remittance, and the background of the transaction.
- If you have any other documents related to the transaction, please bring them with you.

◎ Passbook and seal

◎ Two-dimension code

Please prepare by above the steps , bring the necessary documents, and visit a nearby branch that accepts foreign remittances.
